We are delighted to present our first Annual Review for the Global Coalition of Parents of Deaf and Hard of Hearing Children (GPODHH). We feel it is time to highlight the achievements of this voluntary group of passionate parent leaders from around the world over the past year.

Since its grassroots beginning under the trees on the sideline of the NHS Conference in Italy in 2008, GPODHH has evolved into a resilient organization, making a significant impact on the global stage. The journey of GPODHH has been a testament to the challenges of not just starting but sustaining a movement. Through the inevitable ups and downs, GPODHH has maintain its identity and experienced growth in both membership and impact. This growth has been instrumental in ensuring that the organization remains an important advocate for children and young people who are deaf or hard of hearing (DHH) and their families.

GPODHH has established itself as a close associate of FCEI International and an active member of the World Hearing Forum and Cochlear Implant International Community of Action (CIICA). Regular participation in seminars and discussions and presenting parents' perspectives on international platforms has solidified GPODHH's presence and influence globally. The organization's involvement in these networks has allowed it to contribute to shaping policies and guidelines that affect DHH children and their families worldwide.

Through its international collaborations, GPODHH receives regular requests for consultation on policy documents, research outputs and other collaborative endeavours. For example, GPODHH members are

part of the team producing the revised Best Practice Principles for Family-Centered Early Intervention (in press) and are leading the development of the easy-read version of the Principles. GPODHH members have a broad range of lived experiences, knowledge and perspectives, and their insights provide important and valuable input to these organisations.

However, as the realization of the crucial role that families can play in the development of programs and research agendas grows, the stark reality of sustaining parent groups is ever present in our meetings. Funding is a constant difficulty for every organization. Most continue to operate because of parents' passion for building a better world for their DHH children. Volunteering results in a high attrition rate, and valuable parent knowledge is lost when parents are not compensated for their contribution. Sustaining effective parent organisations requires funding. As GPODHH continues to evolve and grow, there is a pressing need for policymakers, program managers, and researchers to factor in funding for family support and consultation when developing their budgets. It would make a world of difference.

In conclusion, the journey of GPODHH, from its humble beginnings under a tree to its current status as a global advocate for DHH children and families, is a testament to the resilience and determination of parents committed to making a lasting impact on the world stage. The organization's achievements and ongoing efforts underscore the importance of collaborative advocacy and the power of collective voices in creating positive change.

As the co-chairs of GPODHH, we embrace the "Declaration on the Rights of Deaf Children" and the imperative that language be accessible to every deaf child. We challenge governments to recognise the importance of language - both signed and spoken - and the rights of deaf children to protection from language deprivation so they can lead productive lives with dignity and self-worth.

Governance

The Global Coalition of Parents of Children who are Deaf or Hard of Hearing (GPODHH) is an international collaboration of parent-led groups and parent leaders. The organisation is entirely voluntary and operates under a Charter which outlines the guiding principles of membership and responsibilities of representatives.

GPODHH does not hold direct funds. Member organizations provide their representatives (parent leaders) with the necessary financial support to participate in GPODHH activities. Funding guidelines promote open, transparent and ethical funding principles.

Consensus decision-making is a hallmark of our collaborative practice.

Bi-monthly meetings of member representatives are held online. The co-chairs meet weekly to progress the work of GPODHH.

A biennial meeting is held in Bad Ischl, Austria, prior to the FCEI Conference with the support of FCEI International.



2008	 The Global Coalition of Parents of Deaf and Hard of Hearing Children is established under the trees at NHS 2008 in Lake Como, Italy. Founding parents - Leeanne Seaver and Janet DesGeorges (Hands & Voices, USA); Ann Porter (Aussie Deaf Kids); Roz Keenan (Deaf Children Australia); Jodi Cutler (Affrontiamo Forum, Italy), and Pauline Walker (National Deaf Children's Society, UK).
2009	 GPODHH (initially GPOD) undertakes a global online survey of families and their support needs. 600 respondents from 23 countries. www.GPODHH.org is registered as a domain name with the assistance of Hands & Voices. A logo is created and the first website is developed using a free platform.
2010	 GPODHH publishes its Position Statement and Recommendations for Family Support in the Development of Newborn Hearing Screening Systems (NHS)/Early Hearing Detection and Intervention Systems (EHDI) Worldwide (June 2010). Results of survey presented at NHS 2010 in Como, Italy.
2012	 Ist International Conference on Family-Centered Early Intervention (FCEI) hosts delegates from around the world in Bad Ischl, Austria. GPODHH invited to organize a pre-conference workshop for parents. GPODHH representatives participate in Consensus meeting following the FCEI Conference and contribute to the development of the principles on family-centered early intervention for children who are deaf or hard of hearing.
2013	 'Best Practices in Family-Centred Early Intervention for Children who are Deaf or Hard of Hearing: An International Consensus Statement' (Moeller et al, 2013) is published by the Journal of Deaf Studies and Deaf Education. Contribution of GPODHH members recognised in publication. Leeanne Seaver (Hands & Voices, USA) is elected GPODHH Chair.
2014	 2nd International Conference on Family-Centered Early Intervention held in Bad Ischl, Austria. GPODHH organizes the pre-conference parent workshop. Communication between GPODHH members mainly through emails.
2015	 GPODHH commences holding regular meetings on Skype although technology and time zones are barriers to effective real-time communication. A closed Facebook group is created by Jodi Cutler (Italy).
2016	 Bianca Birdsey (South Africa) chairs the Family Support Committee. Teresa McDonnell (Ireland) chairs GPODHH's Strategic Planning Committee. GPODHH organizes the pre-conference parent workshop at the 3rd International Conference on Family-Centered Early Intervention. Membership of GPODHH grows as new connections are made at the conference.

- GPODHH holds the first of its biennial meetings in Bad Ischl, Austria, prior to the 4th FCEI
- The parent workshop focused on strategies to help families and professionals identify DHH children at risk for or experiencing abuse and neglect.
- GPODHH representatives Bianca Birdsey (South Africa) and Anisa Ibrahimovic (Bosnia-Herzegovina) attend the 3rd Stakeholders' meeting for the WHO programme on prevention of deafness and hearing loss in July at the WHO Headquarters, Geneva, Switzerland.
- Snigdha Sarkar (India) represents GPODHH at Stakeholder Meeting in December at WHO Headquarters
- GPODHH establishes a WHO Working Group to support its representatives at the WHO meetings.
- Bianca Birdsey (South Africa) and Snigdha Sarkar (India) attend meeting in August at the WHO Headquarters, Geneva, Switzerland.
- GPODHH becomes a member of the World Hearing Forum and representatives Bianca Birdsey (South Africa), Snigdha Sarkar (India), Ann Porter (Australia) and Nicole Schilling (Germany representing FEPEDA) attend the First Membership Assembly of the World Hearing Forum in
- GPODHH representatives, joined by Jodi Cutler (Italy) meet with Dr Shelly Chadha following the meeting to discuss the parent partnerships in the work of the WHF.
- GPODHH's biennial meeting is done virtually as all in-person meeting and travel is cancelled due to the COVID Pandemic.
- Leeanne Seaver (USA) steps down as GPODHH Chair, and a new team steps up: Snigdha Sarkar (India) and Ann Porter (Australia) who will co-chair the organisation.
- GPODHH becomes a member of the Cochlear Implant International Community of Action (CIICA)
- Resources compiled on Child Safeguarding for families and people working with children who
 are deaf or hard of hearing addressing the urgency of increased risk of abuse and neglect
 for DHH children worldwide.
- A small contingent of members joined the biennial meeting which was held prior to the FCEI Conference in Bad Ischl, Austria.
 - First strategic plan was approved to shape the work of GPODHH going forward.
